##### **Military Matters**

The Mayor was looking forward to welcoming the 1<sup>st</sup> Battalion the Royal Anglian Regiment home from Afghanistan when they march through Ipswich on their homecoming parade on Monday 5<sup>th</sup> November 2012 at 12.30pm.

On Friday 9<sup>th</sup> November, local schoolchildren will place poppy crosses on graves in the Fields of Honour at the Old Cemetery. The Mayor and the Deputy Mayor will be present for this service which starts at 10.30am.

On Sunday 11<sup>th</sup> November the Mayor hopes to see many of you at the Remembrance Sunday Service at the Cenotaph in Christchurch Park. Again, the service gets under way at 10.30am.

The Mayor was privileged to welcome the Soldier Ride UK at Christchurch Park when they came to Ipswich recently, organised by the British Limbless Ex Service Men's Association. A group of 30 amputee servicemen, women and veterans from the US and UK joined forces to conquer a 250-mile cycling trek to raise awareness of the challenges they face after injury.

The signing of the Military Covenant in Suffolk took place at Suffolk County Council's offices in early October and Ipswich Borough Council was pleased to support this initiative.

Ipswich has enjoyed a wonderful array of events this summer, including The Queen's Jubilee celebrations in Christchurch Park, the Olympic Torch, Ipswich Maritime, Larkin Gowen Half Marathon, and the Ipswich Skyride to name but a few. ##### **Ipswich's History**

**7. C/12/09 To consider a report from the Monitoring Officer on the Arrangements for Local Choice Non-Pecuniary Interests under the Localism Act 2011**

It was **RESOLVED:-**

(i) that the following categories of 'local choice' Non-Pecuniary Interests (LNPIs) in respect of the Suffolk Code of Conduct be adopted:

1. Anybody of which you are a member or in a position of general control or management and to which you are appointed or nominated by the Council;

2. Anybody:

(a) exercising functions of a public nature;

(b) directed to charitable purposes; or

(c) one of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union);

of which you are a member and in position of general control of management;

3. Any person from whom you have received a gift or hospitality with an estimated value of at least £25.

(ii) that the Head of Legal and Democratic Services be authorised to make consequential changes to the Council's Constitution.

**8. C/12/10 To consider a report from the Monitoring Officer on the Appointment of Independent Persons**

It was **RESOLVED:**

- (i) that the appointment of the 8 individuals listed in Appendix 1 of the report be appointed as Independent Persons for the Borough Council for a period of 1 year, commencing on the date of this meeting, with an option on the part of the Council to extend any appointment for up to 2 years;
- (ii) that the joint administration arrangements detailed in the report in respect of the pool of Independent Persons be noted;
- (iii) that the Council's Monitoring Officer arranges for a further targeted recruitment campaign to be undertaken (with a view to adding to/and or replacing all or some of the pool of Independent Persons), which takes into account the need to attract a greater number of applicants to the pool from more diverse backgrounds – the selection panel for this exercise is to be determined by the Monitoring Officer in consultation with the Chief Executive and the Leader;
- (iv) that the Monitoring Officer reports back to Council on the outcome of the further recruitment campaign in due course.
